1. Select any *three* of the following ports and discuss their position and the nature of their trade:—Auckland, Esbjerg, Rotterdam, Stockholm, Trondhjem.

2. Contrast the part played by climate in the economic life of Ireland and Scandinavia.

or

Compare Ireland and Denmark in respect of their economic geography.

3. The annual foreign trade per head of the population in the following countries is:—

Denmark	£40 18
Netherlands	£35 7
New Zealand	£35 5

Explain these figures as fully as you can on a geographical basis.

or

How do you account for the fact that on the basis of the agricultural land (per 1,000 acres crops and pasture) the import and export trade of Denmark in agricultural produce is relatively greater than that of Saorstát Eireann?

4. Describe and account for the distribution of population in *either* Norway *or* New Zealand.

5. Compare the east coast of Scandinavia with the west coast as regards structure, climate and trade.

or

Write a comparative note on the transport systems of The Netherlands and of New Zealand.
